### **New Business:**

Library BCCLS Wi-Fi

Wi-Fi challenges due to a firewall issue during a planned PSE&G electricity outage accelerated the investigation of migrating the library service from Verizon to BCCLS. The Director completed an assessment of the BCCLS offering and a side-by-side comparison of the two vendors (attached). There is the possibility of an increase of 1 access point (to 6 total) for the meeting room; this assumption is included in the comparison. The analysis reveals an estimated year 1 cost increase of \$458 versus plan; however, this is offset by combined estimated savings in years 2 and 3 of \$5.8K. The savings would carry onward with projected improved bandwidth / service for patrons. Further, the service burden would be transferred in part to BCCLS. The Director proposed that the \$1,779 year-1 hardware cost be funded from the Operating Budget.

A motion to approve the migration of the library Wi-Fi service provider from Verizon to BCCLS at a cost of \$1,779 and funded by the Operating Budget was made by Deanna Pagano and seconded by Bernice Bonnett. All voted in favor and the motion passed.
